STEPS TO PARTICIPATE

1. Check your barns, sheds, basement, attic, or garage for hazardous chemicals
2. Due to reductions in funding, we will be charging participants to drop off their waste
3. The cost will be \$20.00 per vehicle for household clean sweep.
4. The cost will be \$20.00 per vehicle for Agriculture clean sweep which includes the 1st 200 pounds of hazardous waste material
5. At the time of pre-registration, a drop-off time will be scheduled and further information given regarding safe handling of hazardous materials
6. Put items in a box lined with a garbage bag to eliminate spillage. Bring them to the Richland County HWY shop at your appointment time
